### **CITIZEN OVERSIGHT COMMITTEE - STREET BONDS (MEASURE K-14)**

**NOTICE IS HEREBY GIVEN** that the City of Grover Beach is seeking volunteers for positions on City Commissions and Committees. The City recruits applicants by publishing Notices of Vacancies in the local newspapers, posting notices in the City's three (3) public posting locations, and posting a notice on the City website and Government Cable Access Channel 20.

**NOTICE IS FURTHER GIVEN** that the City of Grover Beach is currently seeking citizens interested in serving on the newly formed Citizen Oversight Committee regarding **Measure K-14, the Street Rehabilitation; Safety Improvement Bond Measure**, which was approved by a two-thirds majority of the voters at the November 2014 General Municipal Election.

**Three (3) seats on the Citizen Oversight Committee - Street Bonds (Measure K-14) are currently open. Members appointed to this Committee are to serve four-year terms of office.**

In accordance with voter-approval of Measure K-14, the Citizen Oversight Committee is composed of three (3) registered voters of the city. The Committee is tasked with reviewing expenditure reports relative to the activities funded with proceeds from the sale of bonds to ensure that the expenditures are made as specified in the voter-approved bond measure for street rehabilitation and repair. The Citizen Oversight Committee then provides a report to the City Council regarding its findings.

Citizen Oversight Committee meetings are scheduled as needed, but not less than once annually. Meetings are open to the public and subject to the Brown Act.
